BILL

1 AN ACT concerning

2 Adoption of the FY1999-2000 Budget of the Parking Authority

3 For the purpose of ratifying and adopting the Current Expense Budget and Capital Improvement
4 Program Budget of the Parking Authority for the Prince George's County for the fiscal year
5 beginning July 1, 1999, and ending June 30, 2000, prepared pursuant to the authority contained
6 in Subtitle 2, Division 27, Prince George's County Code, 1995 Edition, as amended;
7 appropriating the items of expense in said current expense budget, establishing proposed
8 amounts for revenues, operating expenses, capital improvement projects, administrative
9 expenses, and other expenses, all to be known as the Current Expense Budget of the Parking
10 Authority of Prince George's County for the Fiscal Year 1999-2000.

11 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
12 Maryland, that subject to and in accordance with the authority of the Charter of Prince George's
13 County, Article 41, Section 14-306 of the Annotated Code of Maryland relating to Parking
14 Authorities, and pursuant to Subtitle 2, Division 27, Prince George's County Code, 1995 Edition,
15 as amended, the several amounts specified in the Current Expense Budget of the Parking
16 Authority of Prince George's County, as submitted by the County Executive to the County
17 Council, a copy of which is attached and incorporated herein by reference and made a part hereof
18 as though it was set forth fully herein, are hereby authorized, approved, and adopted for the fiscal
19 year beginning July 1, 1999, and ending June 30, 2000.

20 SECTION 2. BE IT FURTHER ENACTED that subject to and in accordance with the
21 authorities referred to in Section 1, supra, the several amounts specified in the Capital

1 Improvement Program Budget of the Parking Authority of Prince George's County, as submitted
2 by the County Executive to the County Council, a copy of which is attached and incorporated by
3 reference and made a part hereof as though it was set forth fully herein, are hereby authorized,
4 approved, and adopted for the fiscal year beginning July 1, 1999, and ending June 30, 2000.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect on July 1, 1999.
