TRANSPORTATION, HOUSING AND ENVIRONMENT COMMITTEE

Committee Vote: Favorable with amendments, 5-0 (In favor: Council Members Harrington, Bland, Dernoga, Exum and Hendershot)

Staff explained the purpose of CR-31-2006 and informed the Committee of comments that were received at the public hearing held on May 16, 2005. The Annual Plan allocates the maximum funding allowed by law to the eligible categories: Public Services Projects (15%) and Program Planning and Administration (20%). The remaining balance is allocated among the eligible activities: acquisition and rehabilitation, economic development, relocation and public facilities.

The Office of Law provided written comments indicating that CR-31-2006 may not comply with the requirements of the County's FY2006 – 2010 Consolidated Plan adopted by CR-41-2005, and amended by CR-81-2005.

The Committee suggested that the revisions to the Consolidated Plan be made by a separate resolution. Specifically, the intent is to require amendments for the CDBG program when significant funds are moved between projects and for other programs, amendments shall only be required when funds are moved between activity categories. The Committee recommended that the appropriate staff meet to determine the impact of the office of Law comments and the necessary remedy.

The Transportation, Housing and Environment Committee reviewed the Annual Action Plan, focusing on each of the above-mentioned categories and proposed changes as reflected in CR-31-2006, Draft 2. In addition, Attachment B was amended as reflected in CR-31-2006 Draft 2. The Committee recommended that the \$250,000 for the HOME Tenant-Based Rental Assistant (TBRA) program be set aside for United Communities Against Poverty's (UCAP) Rental Allowance Program (RAP). The Committee recommended HOME program administrative allocation be set aside for UCAP to run the URAP program in the amount of \$150,000; and that prior to enactment, the Council will make a recommendation on the remaining balance of \$139,355. On May 23, 2006, the DHCD provided the THE Committee with a briefing on the HOME Program. At which time, an aging report was requested providing the dollar amount and age summary of the breakdown.

This resolution will approve and adopt the FY 2007 Housing and Community Development Annual Action Plan including Federal entitlements for: Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), American Dream Down Payment Initiative (ADDI) and the Emergency Shelter Grant (ESG) programs, and will program \$2,190,400 in uncommitted entitlement funds generated from greater than anticipated program income received during the past three years.
