Public Safety Article Section 1-311 of the Annotated Code of Maryland was amended by Chapter 349 of the 2022 legislative session to permit a County to increase its 911 fee to recover the actual County cost of providing that service.

The County completed the FY 2021 audit of 911 fee revenue and the cost of providing service, and found that County expenses exceeded 911 fee revenue by \$9.0 million, however this does not reflect the additional revenue effective July 1, 2023 when the fee level was increased to \$1.40 per line. To recover the cost of service would require that the fee be raised by \$0.01 cent per line, to a revised total of \$1.41 per line. To do so, State law requires the County to hold a public hearing on the proposed fee increase, and upon adoption of a Resolution to notify the Public Service Commission. The Public Service Commission requires 60 days to notify telephone service providers before the fee goes into effect.

RENT STABILIZATION TASK FORCE REPORT AND RECOMMENDATIONS

The briefing convened at 12:03 p.m. Chair Ivey introduced Bithia Ratnasamy Palmer, Director, Equitable Housing Solutions, who introduced, Melissa Bondi and Christina Plerhoples Stacy. Ms. Palmer then facilitated a Powerpoint Presentation titled, "Designing and Implementing a Rent Stabilization Policy in Prince George's County". The presentation highlighted the following: Prince George's County has lower asking rent per square foot than nearby jurisdictions for multi-family rentals; However, Prince George's County also has a lower median income than nearby jurisdictions; The percent of rent burdened households in Prince George's County is higher than in nearby jurisdictions; While average rent increases in the county are often near or below inflation, there is great variation in rent changes by property type with some increases as high as 20 percent; Rent Stabilization Act of 2023; The County also convened a work group to design a permanent rent stabilization measure for the county; What is rent stabilization; The role of rent stabilization policies; Rent stabilization regulations must be designed with balance in mind; Core components of rent stabilization policies; Core components of Montgomery County's rent stabilization policies; Montgomery County: Next Steps; Learnings Considerations Recommendations; Limitations on rent increases; Exemptions; Exceptions; Decontrol; Related tenant protections; Key Administration Considerations; What is required to establish a rent stabilization policy; How should the policy be enforced; What penalties do jurisdictions use; What systems should a jurisdiction have to manage a rent stabilization policy; What types of ongoing outreach and education are needed; and Rent stabilization cannot work on its own. The panelists responded to questions from Council Members. The briefing concluded at 12:52 p.m.
