# 1. <u>PUBLIC HEARING – RESOLUTION ELIGIBLE FOR FINAL READING</u> (ADOPTION)

CR-15-2011 - A RESOLUTION CONCERNING HOUSING AND COMMUNITY DEVELOPMENT NEIGHBORHOOD STABILIZATION PROGRAM ROUND 3 for the purpose of amending the Prince George's County Annual Action Plan: FY 2011 to serve as the application for a Neighborhood Stabilization Program Round 3 ("NSP3") grant to assist the County with the purchase and redevelopment of abandoned and foreclosed homes and residential properties. - PUBLIC HEARING HELD; CONVENED AS C.O.W.; FAVORABLY RECOMMENDED AS AMENDED; DR-2 ADOPTED

(Introduced by Council Members Toles, Harrison, Franklin and Turner on 2/1/2011)

Pursuant to proper notice, the public hearing convened on Council Resolution 15. Betty Hagar Frances, Rozlyn Clemmons, Chad Williams and Mike Cerrito spoke in support of the legislation. All person wishing to speak having done so, the public hearing was declared held. Chair Turner convened the Committee of the Whole, wherein Todd Turner, Legislative Officer, provided an overview of the legislation and responded to questions raised by Council. Council Member Toles moved a favorable committee recommendation; seconded by Council Member Olson. Council Member Toles proffered a substitute motion to include amendments; seconded by Council Member Franklin. The motion carried by roll call vote of 9-0. The main motion, now for a favorable recommendation with amendments carried by roll call vote of 9-0. Chair Turner reconvened the Council Session. Todd Turner, Legislative Officer, provided a verbal report of the actions and recommendations of the Committee of the Whole. Council Member Toles moved adoption of Council Resolution 15, Draft 2; seconded by Council Member Olson. The motion carried by roll call vote of 9-0.
