The Government Operations and Fiscal Policy Committee met on June 13, 2019 to consider the reappointment of one Member and four nominees to the Personnel Board. The Personnel Board plays a vital role in the interpretation and adjudication of the personnel law, County regulations and administrative policies all of which are critical to the fair and efficient operation of County Government.

Delores Stuckey, Chair Designate, is being reappointed. Ms. Stuckey is a resident of Bowie and is the Chief of the Learning and Development Division at the Pension Guaranty Corporation. She is responsible for all corporate-wide learning and development activities. Prior to that Ms. Stuckey worked at the Graduate School U.S. Department of Agriculture in management and leadership development training. Ms. Stuckey has a B.S. from Howard University and an M.A. from Georgetown University.

The following persons are being appointed:

Ms. Yvonne Hefley, of Oxon Hill, retired from the Federal Government after thirty (30) years of service. She serves as a Mediator for the Prince George's County Community Mediation Program, the District Court of Maryland (small claims) and the Montgomery County Circuit Court (Child in need of Assistance Cases).

Ms. Darlene Neal, of Temple Hills, is an experienced human resources management professional. She has over two decades of experience in policy writing, retirement consultation, claims examination /adjudication, merit staffing, position classification, and performance management. Ms. Neal received her B.S. degree from Strayer University. She is also a graduate of the USDA Executive Potential Program.

Ms. Gwendolyn Townsend, of Upper Marlboro, is a results-oriented federal government employee with decades of experience in the areas of human resources management, organizational leadership, process improvement and workforce development. She currently serves as a Program Analyst with the United States Department of Justice Drug Enforcement

Administration. Ms. Townsend received her B.S. degree from the University of Maryland College Park and her M A. degree from Bowie State University.

Mr. Ike Udejiofor, PhD, of Glenn Dale, has over twenty -five (25) years of well-rounded experience in the field of governmental human resources. He has an in-depth experience in development, management, and interpretation of laws, rules, regulations and processes applicable to classification, compensation, recruitment, staffing, and employer-employee relations. Mr. Udejiofor obtained two bachelor's degrees from the University of Iowa, Iowa City, in Political Science and Journalism, a MPA from the University of Nebraska and a Doctorate degree in Public Administration from Howard University.

The Committee questioned each nominee concerning their prowess on personnel issues and thanked each for their desire to serve on the capacity.

The Government Operations and Fiscal Policy Committee voted the appointments of all candidates out favorably, 4-0.
