RESOLUTION

1 A RESOLUTION concerning

2 Housing and Community Development

3 Annual Action Plan: FY 2011

4 For the purpose of amending the Prince George’s County FY 2011 Annual Action Plan for
5 Housing and Community Development to reprogram, restructure and approve Community
6 Development Block Grant (“CDBG”) and Community Development Block Grant Recovery
7 (“CDBG-R”) activities related to housing and community development.

8 WHEREAS, pursuant to Subtitle 15A-103 of the Prince George’s County Code, as
9 amended, the County Executive submitted a citizen participation plan in conjunction with the
10 FY 2011-2015 Consolidated Plan for Housing and Community Development to the County
11 Council; and

12 WHEREAS, the citizen participation plan was adopted by CR-26-2010 and provided for
13 citizen involvement in the various stages of Housing and Community Development activities and
14 lists the actions which are subject to the citizen participation plan; and

15 WHEREAS, pursuant to Section 15A-105(a)(2) of the County Code, the FY 2011 Annual
16 Action Plan must be amended to include the estimated cost of projects, the total cost to bring
17 them to completion, and an identification of the sources of funds; and

18 WHEREAS, Attachment “A” includes the projects within CDBG Program Years 31
19 through 36 (*i.e.*, FY 2006 through FY 2011) and CDBG-R Program Year 1 (*i.e.*, FY 2009) that
20 were approved in prior Annual Action Plans and that need to be reprogrammed and reallocated
21 to new activities.

22 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's

1 County, Maryland, that the Prince George’s County FY 2011 Annual Action Plan for Housing
2 and Community Development is hereby amended to reprogram, restructure and approve CDBG
3 and CDBG-R activities related to housing and community development as set forth in
4 Attachment “A”.

5 BE IT FURTHER RESOLVED that upon adoption of the Resolution, it shall be transmitted
6 to the County Executive by the Clerk of the Council to submit the amended Annual Action Plans
7 to the U.S. Department of Housing and Urban Development.
