### EXECUTIVE ORDER

**No. 6 - 2023**

**June 9, 2023**

**WHEREAS**, the County Executive transmitted the Proposed Operating and Capital Budget for Fiscal Year 2024 on March 15, 2023, to the County Council of Prince George's County, Maryland in accordance with the authority of the Charter of Prince George's County, the public general laws and public local laws of Maryland relating to budget procedures, and pursuant to applicable local ordinances heretofore enacted; and

**WHEREAS**, the County Executive adjusted the Proposed Budgets on May 24, 2023, to reflect certain actions contained within the FY 2024 State of Maryland approved Budgets and other adjustments reflected in my letter dated May 24, 2023; and

**WHEREAS**, the County Council adopted CB-63-2023 on May 25, 2023, approving the Fiscal Year 2024 Operating and Capital Budgets that authorizes and appropriates for the several purposes specified, beginning July 1, 2023 and ending June 30, 2024; and

**WHEREAS**, the County Council delivered the approved Budget on May 26, 2023, for disapproval or reduction of any line item in the approved Budget within ten days thereafter pursuant to section 411 of the Prince George's County Charter; and

**WHEREAS**, the County Executive has stated by letter to the County Council dated June 7, 2023, incorporated by reference, her reasons to exercise budget veto power as authorized by Section 411 of the Prince George's County Charter, on certain items contained in the approved Budget; now, therefore

**IT IS HEREBY ORDERED**, on this 9th day of June, 2023, that I, Angela D. Alsobrooks, County Executive for Prince George's County, Maryland, pursuant to the provisions of Section 411 of the Prince George's County Charter to disapprove or reduce line items in the FY 2024 Current Expense and Capital Budgets, as adopted by the Prince George's County Council on May 25, 2023 in CB-63-2023 that:
