**BILL**

1 AN ACT concerning

2 Fine Dining Incentive Act of 2026

3 For the purpose of establishing a Prince George's County Fine Dining Incentive Program to  
4 attract more fine dining restaurants to locate and expand in Prince George's County; reserving a  
5 certain percentage of annual awards from the Prince George's County Economic Development  
6 Incentive Fund for the Prince George's County Fine Dining Incentive Program; providing for the  
7 administration and regulation of the Prince George's County Fine Dining Incentive Program;  
8 providing for the abrogation of the program; and generally relating to the Prince George's  
9 County Fine Dining Incentive Program.

11 SUBTITLE 10. FINANCE AND TAXATION.

12 Section 10-366,

15 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
16 Maryland, that Section 10-366 of the Prince George's County Code be and the same is hereby  
17 added:

18 SUBTITLE 10. FINANCE AND TAXATION.

19 **DIVISION 38. FINE DINING INCENTIVE PROGRAM.**

20 **Sec. 10-366. Prince George's County Fine Dining Incentive Program.**

21 (a) Definitions. In this Division, the following words shall have the following meanings:

1           (1) **Executive chef** means the high-level manager and highest-ranking culinary position  
2 with chief responsibility for all kitchen operations, food production personnel, and culinary  
3 functions at a fine dining restaurant. The executive chef is wholly or partially responsible for  
4 menu planning, recipe development, kitchen staff management, and maintenance of culinary  
5 safety and quality standards at a fine dining restaurant.

6           (2) **Fine Dining Restaurant** means a sit-down restaurant offering a premium experience  
7 characterized by exceptional cuisine, high-quality ingredients, and superior service. A fine dining  
8 restaurant must also serve its customers with non-disposable dinnerware and employ an  
9 executive chef.

10          (3) **Sit-down restaurant** means a restaurant, as defined pursuant to Part 27-5 of Subtitle  
11 27 of the Code, whose principal method of operation consists of sit-down table service provided  
12 by dedicated waitstaff for on-site food and beverage consumption. Restaurants whose principal  
13 method of operation is counter service, quick service, or carryout food and beverage service for  
14 offsite consumption, or that provide drive-through service, are not sit-down restaurants under this  
15 Subsection.

16          (b) **Prince George's County Fine Dining Incentive Program.** At least 10% of the annual funds  
17 authorized for the Economic Development Incentive Fund shall be awarded to operators of fine  
18 dining restaurants seeking to locate or expand in Prince George's County, provided that at least  
19 70% of such funds be awarded annually to attract fine dining restaurants to locate or expand in  
20 the area of Prince George's County between the border with the District of Columbia and the I-  
21 495 Capital Beltway.

22          (c) **Administration.** The Prince George's County Fine Dining Incentive Program shall be  
23 administered in accordance with the process for administering Economic Development Incentive  
24 Fund awards.

25          (d) **Additional funding.** Additional funds may be allocated to the Economic Development  
26 Incentive Fund for the designated purpose of being awarded in accordance with the Prince  
27 George's County Fine Dining Incentive Program.

28          (e) **Regulations authorized.**

29          The County Executive may promulgate regulations to administer the Prince George's  
30 County Fine Dining Incentive Program in accordance with this Division, subject to approval by  
31 County Council resolution.

1 (f) Reporting. By August 31 of each year, the County Executive or their designee shall  
2 provide an annual written report to the County Council on the progress of the Prince George’s  
3 County Fine Dining Incentive Program during the previous fiscal year.

4 SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act shall be  
5 abrogated and of no further force and effect on January 1, 2030, unless extended by the County  
6 Council prior to that date.

7 SECTION 3. BE IT FURTHER ENACTED that the provisions of this Act are hereby  
8 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,  
9 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of  
10 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining  
11 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this  
12 Act, since the same would have been enacted without the incorporation in this Act of any such  
13 invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection,  
14 or section.

15 SECTION 4. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)  
16 calendar days after it becomes law.
