ORDER OF DISMISSAL ON REMAND

On October 6, 2025, using oral argument procedures, the District Council, on remand,

reviewed the decision of the Planning Board, embodied in Resolution 2025-008 (A), to approve,

among other things, Detailed Site Plan (DSP) 22001, a proposed development to construct a 3,683-

square-foot eating and drinking establishment with drive-through service on the southern portion

of the subject property, Parcel 23, located in the northeast quadrant of the intersection of MD 410

(East West Highway) and Van Buren Street, and on the south of Ager Road, as shown on Tax Map

41-D1 in Planning Area 65 and Council District 2. The District Council's review of the Board's

decision also included consideration of written and oral testimony from certain persons of record

and the Applicant/McDonald's.

On October 15, 2025, before the District Council issued its final decision on remand, the

Applicant, McDonald's USA LLC, withdrew the application in DSP-22001. Gibbs Letter to Clerk

On October 21, 2025, the District Council directed staff to prepare this order of dismissal.
