##### PUBLIC SAFETY AND FISCAL MANAGEMENT

**Date 2/22/2006**

Committee Vote: Favorable as amended, 3-0, (In favor: Councilmembers Peters, Harrington and Knotts.)

This bill will amend the County's Classification Plan by abolishing the Sheriff Dispatcher I, II and III classes of work in Salary Schedule Z. These positions are no longer used by the Office of the Sheriff. All dispatch functions are presently supervised by the Public Safety Communications Unit of the Office of Homeland Security. The proposed amendment is the result of a Public Employee Relations Board Amendment of Certification of Representation AAA Case Numbers 16 39 00196 92 DS and 16 39 00197 92 DS.

The Office of Law has reviewed the legislation and finds it to be in proper legislative form with no legal impediments to its enactment.

The bill was amended:

1. On page 1, line 5, delete 16 3900 916 92 DS and insert 16 3900 196 92 DS.

There will be no negative fiscal impact on the County as a result of enacting CB-8-2006.
