Dear Chair Burroughs:

It is my pleasure to submit to you and the County Council the appointment of the Honorable Darryl Barnes as Chair, Maryland-National Capital Park and Planning Commission (M-NCPPC).

The Honorable Darryl Barnes is a former State Delegate who represented Legislative District 25 from 2015 to 2023. However, long before serving in the Maryland General Assembly, Mr. Barnes established his roots in Prince George's County, completing his formal education by attending Prince George's County Public Schools, having lived in the County for nearly five decades. Currently, he serves as the President and CEO of the Bi-County Business Roundtable. The Bi-County Business Roundtable is an organization representing businesses throughout Maryland. It is one of the largest roundtables in the State and the surrounding Washington Metropolitan region. BCBR has earned a well-deserved reputation as the "Voice of the voiceless and the go-to for small businesses."

In addition, Mr. Barnes serves as President and CEO of Barnes International. Barnes International is a highly regarded bipartisan government relations firm based in Prince George's County. Barnes International provides representation throughout the country as well as internationally; the firm serves clients at all levels of State government. Barnes International engages in providing strategic government relations, lobbying, and procurement services.

Former Delegate Darryl Barnes has been a distinguished leader in Maryland politics, serving as Chief Deputy Majority Whip in 2023 and as Chairman of the Maryland Legislative Black Caucus—the largest Black caucus in the country—for three consecutive terms. As Chairman Emeritus, he championed equity and inclusion; most impressively, he was instrumental in settling the 15-year HBCU lawsuit to provide equitable and fair funding to the State's four HBCUs. In addition, he served on the Ways and Means Committee, overseeing state economic development policies and tax structures. Finally, he was the Chairman of two subcommittees that oversaw state revenues.

Mr. Barnes pursued leadership studies at George Washington University, obtained a PMP Certification, and attended Long Beach State College to study computer information systems.
