WHEREAS, the	Maryland Department of Business and Economic Development and Prince	
George's County Eco	nomic Development Corporation have entered into a joint conditional letter	
of commitment with	Vocus dated March 30, 2010, copy attached as Exhibit "A" and	
incorporated herein b	y reference, to provide a loan from MEDAF in an amount not to exceed	
\$400,000 (the "MED	AF Loan"); and	
WHEREAS, the	MEDAF Loan is authorized under the Maryland Economic Development	
Assistance Authority	and Fund statute set forth in Sections 5-301 through 5-349 of the Economic	
Development Article	of the Annotated Code of Maryland, as amended (the "Act"); and	
WHEREAS, the	proceeds of the MEDAF Loan are expected to be used to reimburse Vocus	
for eligible costs of re	elocating and expanding its present business operations in the County; and	
WHEREAS, it is	s expected that project costs will total approximately \$6.5 million which	
will be funded, in par	t. by: (1) the MEDAF Loan: (2) a County loan not to exceed \$40.000 (at	

WHEREAS, under Sections 5-319(d)(1) and (2)(ii) of the Act, a formal resolution of the

least 10% match of the MEDAF Loan is required under Section 5-319(d)(2)(ii) of the Act), from

the County's Incentive Leverage Fund, managed by the Prince George's County Economic

Development Corporation (the "County Loan"); and

governing body of the County is required to endorse the MEDAF Loan; and

WHEREAS, the County Council and County Executive have determined, based upon the findings and determinations set forth herein, that it is in the best interests of the citizens and residents of the County that the County Council and County Executive endorse the MEDAF Loan and authorize the County Loan, as set forth in Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED by the County Council and the County Executive of Prince George's County, Maryland, that the recitals in the WHEREAS clauses to this resolution are hereby incorporated herein by reference and deemed a substantive part of this resolution.

BE IT FURTHER RESOLVED that the loan from the Maryland Economic Development Assistance Fund to Vocus in an amount not to exceed \$400,000 as set forth in Exhibit "A" or any revision thereof, is hereby endorsed by the County Council and County Executive.

BE IT FURTHER RESOLVED that the County Loan from the County to Vocus in an amount not to exceed \$40,000 from the County's Incentive Leverage Fund, managed by the Prince George's County Economic Development Corporation, on substantially the same terms and conditions of the MEDAF Loan, is hereby approved.

BE IT FURTHER RESOLVED that the County Executive and/or other appropriate officials of the County are hereby authorized and empowered to execute on behalf of the County such documents, instruments and certificates as are necessary or appropriate to consummate the MEDAF Loan and the County Loan.

BE IT FURTHER RESOLVED that this resolution shall become effective as of the date of its adoption.
