RESOLUTION

1 A RESOLUTION concerning

2 Housing and Community Development

3 Annual Action Plan, as amended: FY 2009

4 For the purpose of amending the Prince George’s County FY 2009 Annual Action Plan for
5 Housing and Community Development to restructure, reprogram and approve Community
6 Development Block Grant Recovery (“CDBG-R”) and Homelessness Prevention and Rapid
7 Re-Housing Program Grant (“HPRP”) activities related to housing and community development.

8 WHEREAS, the CDBG-R program established under Title XII of the American Recovery
9 and Reinvestment Act (“Recovery Act”) carries out, on an expedited basis, eligible Community
10 Development Block Grant (“CDBG”) program activities under Title I of the Housing and
11 Community Development Act of 1974 (42 U.S.C. 5301 *et seq.*); and

12 WHEREAS, the HPRP program established under Title XII of the Recovery Act is to
13 provide for homelessness prevention assistance to households who would otherwise become
14 homeless and to provide assistance to rapidly re-house persons who are homeless as defined
15 under section 103 of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11302); and

16 WHEREAS, pursuant to Section 15A-103 of the Prince George’s County Code, as
17 amended, the County Executive submitted a citizen participation plan in conjunction with the
18 FY 2011-2015 Consolidated Plan for Housing and Community Development to the County
19 Council; and

20 WHEREAS, the citizen participation plan was adopted by CR-26-2010 and provided for
21 citizen involvement in the various stages of Housing and Community Development activities and
22 lists the actions which are subject to the citizen participation plan; and

1 WHEREAS, pursuant to Section 15A-105(a)(2) of the County Code, the FY 2009 Annual
2 Action Plan must be amended to include the estimated cost of projects, the total cost to bring
3 them to completion, and an identification of the sources of funds; and

4 WHEREAS, Attachment "A-1" includes the projects within CDBG-R Program Year 1,
5 (*i.e.*, FY 2009) that were approved in a prior Annual Action Plan and that need to be
6 restructured, reprogrammed and reallocated to existing activities previously funded with
7 CDBG-R funds; and

8 WHEREAS, Attachment "A-2" includes the projects within HPRP Program Year 1, (*i.e.*,
9 FY 2009) that were approved in a prior Annual Action Plan and that need to be reprogrammed
10 and reallocated to an existing activity previously funded with HPRP funds; and

11 WHEREAS, Attachment "B" includes the draft FY 2009 Annual Action Plan, as amended.

12 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
13 County, Maryland, that the Prince George's County FY 2009 Annual Action Plan for Housing
14 and Community Development is hereby amended to restructure, reprogram and approve
15 CDBG-R and HPRP activities related to housing and community development, as described in
16 Attachments "A-1, A-2, and B".

17 BE IT FURTHER RESOLVED that upon adoption of the Resolution, it shall be transmitted
18 to the County Executive by the Clerk of the Council to submit the amended Annual Action Plan
19 to the U.S. Department of Housing and Urban Development.
