**RESOLUTION**

1 A RESOLUTION concerning

2                   The Enactment of a Certain Ordinance of the City of College Park

3 FOR the purpose of approving the enactment of Ordinance 07-O-12, amending Chapters 110 and  
4 141 of the City of College Park Code concerning residential parking and storage.

5           WHEREAS, the City Council of the City of College Park, after a public hearing conducted  
6 on June 12, 2007, enacted Ordinance 07-O-12 concerning residential parking and storage; and

7           WHEREAS, this Ordinance (which is attached hereto and incorporated herein as  
8 Attachment A, and hereinafter referred to as the "Ordinance") amended the City of College Park  
9 Code Chapters 110 and 141; and

10           WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code authorizes  
11 municipalities within the Maryland--Washington Metropolitan District to enact ordinances  
12 concerning residential parking and storage on land either zoned for residential or commercial use  
13 or adjacent to residential or commercial zones for the purpose of preserving, improving and  
14 protecting the general character and design of lands within the corporate limits of the  
15 municipality, provided that such ordinances impose stricter or additional limitations or  
16 restrictions than are otherwise imposed by the County zoning regulations; and

17           WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code provides that  
18 such ordinance shall not be effective until approved by the County Council of Prince George's  
19 County, sitting as the District Council; and

1 WHEREAS, the City of College Park, pursuant to Section 8-112.1 of Article 28 of the  
2 Maryland Annotated Code, has delivered a certified copy of the Ordinance to the District  
3 Council; and

4 WHEREAS, the District Council has determined that the Ordinance imposes additional  
5 conditions upon residential parking and storage than those currently imposed by Subtitle 27 of  
6 the Prince George's County Code (the "Zoning Ordinance").

7 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
8 County, Maryland, sitting as the District Council for that part of the Maryland-Washington  
9 Regional District in Prince George's County, Maryland, that Ordinance 07-O-12 of the City of  
10 College Park, as represented in Attachment A to this Resolution, be and is hereby approved.
