REPORT: Committee Vote: Favorable As Amended 4-0 (In Favor: Councilmembers Toles, Davis, Harrison, and Turner)

This bill will provide supplementary appropriations for FY 2015 in the amount of \$305,300 to the General Fund. The additional funds will increase the FY 2015 General Fund budget from \$2,857,220,500 to \$2,857,525,800. The additional \$305,300 is additional General Fund revenues for FY 2015 is declared from the County's available fund balance.

The \$305,300 in General Fund revenue will be used to support 28 volunteer fire stations based on payments not distributed in FY 2013. The reconciliation of the FY 2014 ambulance receipts is in progress.

The Office of Law has reviewed this bill and finds it to be in proper legislative from with no legal impediments to its enactment.

The attached listing of Ambulance Fire – Station Allocations were amended by adding "Marine Fire Rescue Volunteer #56/57, \$5,214 for allocation and deleting \$299,861.88 and inserting \$305,255.41.

The enactment of CB-90-2014 will have a negative fiscal impact on the County as a result of the \$305,300 reduction in the County's Fund Balance.
