BILL

1 AN ACT concerning

2 Deceptive Trade Practices by Landlords

3 For the purpose of enhancing tenant protections under consumer protection laws in response to
4 widespread issues facing tenants from landlord's unfair or deceptive practices.

5 BY repealing and reenacting with amendments:

6 SUBTITLE 2. ADMINISTRATION.

7 Section 2-146

8 The Prince George's County Code

9 (2023 Edition; 2024 Supplement).

10 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
11 Maryland, that Section 2-146 of the Prince George's County Code be and the same is hereby
12 repealed and reenacted with the following amendments:

13 SUBTITLE 2. ADMINISTRATION.

14 DIVISION 8. CONSUMER PROTECTION.

15 SUBDIVISION 1. GENERAL.

16 **Sec. 2-146. Unlawful practices.**

17 * * * * *

18 (e) The following practices and conduct are declared to be unlawful, unfair and deceptive
19 in connection with actions by landlords with respect to rental housing:

20 (1) Failure of the landlord to correct substandard living conditions of their rental

1 properties.

2 (2) Landlord’s misleading advertising of amenities of their rental properties.

3 (3) Landlord’s failure to maintain essential services required on their rental
4 properties.

5 (4) Unwarranted fees assessed by landlords upon tenants in their rental properties.

6 (5) Persistent housing violations by landlords on their rental properties.

7 SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby
8 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,
9 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of
10 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining
11 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this
12 Act, since the same would have been enacted without the incorporation in this Act of any such
13 invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection,
14 or section.

15 SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
16 calendar days after it becomes law.
