For the purpose of ame	ending the compensation of the County Executive and members of the		
County Council.			
WHEREAS, Sect	ion 308 of the Charter of Prince George's County, Maryland, provides		
that the compensation	of Councilmembers may be changed by an affirmative vote of not less		
than two-thirds of the r	members of the Council; and		
WHEREAS, Sect	ion 406 of the Charter of Prince George's County, Maryland provides tha		
the compensation of th	e County Executive may be changed by an affirmative vote of not less		
than two-thirds of the r	members of the Council; and		
WHEREAS, any	increase in compensation which becomes law during one term of office		
shall not become effect	tive before the next term; and		
WHEREAS, the 2	2001 Charter Review Commission reviewed the compensation of		
Councilmembers and E	Executives in comparable jurisdictions; and		
WHEREAS, the	Commission found that an increase in compensation is justified for both		
the members of the Co	unty Council and the County Executive; and		
WHEREAS, the	compensation for the County Executive was last addressed legislatively in		
1974; and			
WHEREAS, the o	compensation for the County Council was last addressed legislatively in		
1986; and			
WHEREAS, it is	appropriate to modify the compensation for members of the County		
Council and the County	y Executive to reflect the duties of the offices and to bring them in line		

with those of comparable jurisdictions; and

WHEREAS, Section 1017 of the Charter of Prince George's County, Maryland, provides that a resolution is a measure adopted by the Council which has the force and effect of law of a temporary or administrative character;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that, the members of the County Council shall receive compensation for the performance of their public duties under the Charter of \$70,000 per annum, beginning on the first Monday in December, 2002, and adjusted annually thereafter on the first Monday in December by a percentage which is seventy-five percent of the percentage by which the Consumer Price Index for the Washington Metropolitan area as of July 31 shall have changed from the preceding July 31st. The compensation of the Chairman of the County Council shall be fixed at \$5,000 per annum in excess of the salary of the other council members during such person's term as Chairman, and the compensation of the Vice Chairman of the Council members during such person's term as Vice Chairman.

BE IT FURTHER RESOLVED that the County Executive shall receive compensation for the performance of his public duties under the Charter of \$130,000 per annum, beginning on the first Monday in December, 2002, and adjusted annually thereafter on the first Monday in December by a percentage which is seventy-five percent of the percentage by which the Consumer Price Index for the Washington Metropolitan area as of August 31, shall have changed from the preceding August 31st.
