The Prince George's County Council's Government Operations and Fiscal Policy convened on October 13, 2022, to consider four appointments to the Human Rights Commission. The Human Rights Commission works to eliminate discriminatory practices within Prince George's County through advocacy, education, mediation, investigation of complaints, and enforcement of discrimination laws.

Mr. Keith B. Adams, a resident of Landover, is a Mission Area Senior Program Manager for the U.S. Department of Agriculture (USDA). He has four (4) decades of federal government experience. Mr. Adams received his undergraduate degree from Shepherd University and his Master of Science degree from the University of Maryland – College Park.

Dr. Traci M. Birckhead, a resident of Bowie, is a Program/Project Manager, Communications Expert, and Business Analyst with over twenty-five years of experience, including twenty (20) directly consulting with government agencies. Dr. Birckhead received her undergraduate degree from the University of Maryland – College Park and her Master of Science, Master's Certificate, and Doctor of Education from George Washington University.

Ms. Roslyn Brown, a resident of Bowie, retired from the Office of the Director of National Intelligence as Director, EEO and Diversity Outreach Officer for Ms. Roslyn Brown, a resident of

She developed policy on harassment in the workplace, disability compliance, and reasonable accommodation. Ms. Brown received her undergraduate degree from Howard University and a Master of Public Administration from George Washington University.

Mr. Daryl D. Jackson, a resident of Oxon Hill, a Project Director with the National Association of Drug Court Professionals and is the staff liaison to the Board of Directors. Mr. Jackson earned his undergraduate degree from Johnson C. Smith University and his Master of Social Work from Cleveland State University in conjunction with the University of Akron. He also possesses an Executive Graduate Certificate in Human Resources: Diversity & Inclusion from Cornell University.

After discussion, the Government Operations and Fiscal Policy Committee reported the nominees, except for Mr. Adams, out favorably 5-0.

On October 19, 2022, the Government Operations and Fiscal Policy Committee considered Mr. Adams's appointment to the Human Right Commission. After questions, the Government Operations and Fiscal Policy Committee favorably voted 4-0 on Mr. Adams's appointment.
