AN ACT concerning

An Interproject Transfer of Appropriations and the Reestablishment of a previously approved Capital Project in the FY1990-1991 Capital

Budget.

FOR the purpose of transferring appropriations between capital projects in the amount of \$1,841,000 from the Contingency Fund to Gladys Noon Spellman Elementary School, Ager Road Bridge Repair, and Cherrywood Lane Extended.

WHEREAS, pursuant to the provisions of Section 818 of the Charter for Prince George's County, Maryland, the County Council may authorize, be legislative act, upon request of the County Executive, interproject transfers of appropriations between capital projects in the Approved Capital Budget; and

WHEREAS, the County Executive deems it desirable to provide additional appropriations for Gladys Noon Spellmen Elementary School (AA 779203), Ager Road Bridge Repair (FD 667132), and Cherrywood Lane Extended, (FD 665371) as currently existing appropriations are inadequate for project completion; and

WHEREAS, the County Executive recommends that appropriations can be transferred from the Contingency Fund, as an excess of appropriations over estimated costs is expected; and

WHEREAS, the use of bond proceeds for the purpose set forth herein is in full compliance with all applicable County laws, including all appropriate bond enabling and bond authorization acts; now, therefore

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Cherrywood Lane Extended, CIP# FD665371, is hereby reestablished as a capital project in the FY1991 Capital Budget.

SECTION 2. BE IT FURTHER ENACTED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1991 Approved Capital Budget is hereby amended, as shown on the Appendices A, B, C, and D, attached hereto, to provide that appropriations are transferred as follows:
