RESOLUTION

1 A RESOLUTION concerning

2 Housing and Community Development

3 Annual Action Plan: FY 2008

4 For the purpose of approving the reprogramming of \$1,300,000 in HOME Investment
5 Partnership funds (“HOME”) from the FY 2000, FY 2001, FY 2002, FY 2003, FY 2004, and FY
6 2005 Annual Action Plans to the FY 2008 Annual Action Plan for the Marlton Plaza Senior
7 Housing project.

8 WHEREAS, CR-79-2007 amended the FY 2008 Annual Action Plan to include the Marlton
9 Plaza Senior Housing project (the “Project”), its estimated cost of completion, and its funding
10 sources; and

11 WHEREAS, Section 15A-105(a)(2) of the County Code requires that annual action plans
12 include the estimated cost of projects, the total cost to bring them to completion, and an
13 identification of the sources of funds; and

14 WHEREAS, the Project, as described in Attachment “A”, requires additional funding for
15 completion; and

16 WHEREAS, Attachment “B” describes the projects from Annual Action Plans FY 2000,
17 FY 2001, FY 2002, FY 2003, FY 2004, and FY 2005 with a total of \$1,300,000 in HOME funds
18 needing to be reprogrammed; and

19 WHEREAS, the County Executive recommends the reprogramming of \$1,300,000 in
20 HOME funds to the Project.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
22 County, Maryland, that the FY 2008 Annual Action Plan is hereby amended to reprogram and

1 reallocate \$1,300,000 in HOME funding to the Project as described in Attachments "A" and
2 "B".

3 BE IT FURTHER RESOLVED that upon adoption of this Resolution, it shall be
4 transmitted to the County Executive by the Clerk of the Council to submit the amended Annual
5 Action Plans to the U.S. Department of Housing and Urban Development.
