include the estimated cost of projects, the total cost to bring them to completion, and an			
identification of the sources of funds; and			
WHEREAS, the Project, as described in Attachment "A", requires additional funding for			
completion; and			
WHEREAS, A	WHEREAS, Attachment "B" describes the projects from Annual Action Plans FY 2000,		
FY 2001, FY 2002, FY 2003, FY 2004, and FY 2005 with a total of \$1,300,000 in HOME funds			
needing to be reprogrammed; and			
WHEREAS, the County Executive recommends the reprogramming of \$1,300,000 in			
HOME funds to the Project.
