**RESOLUTION**

1 A RESOLUTION concerning

2 The Addition of Supplementary Appropriations

3 For the purpose of providing supplementary appropriations and amending the Capital  
4 Improvement Program of the Revenue Authority of Prince George's County for Fiscal Years  
5 2017-2022.

6 WHEREAS, the Charter of Prince George’s County provides for the adoption of the budget  
7 to the Revenue Authority, which includes the capital budget and program; and

8 WHEREAS, CR-35-2016, as adopted, enacted the Fiscal Year 2017-2022 Capital  
9 Improvement Program for the Revenue Authority; and

10 WHEREAS, pursuant to CR-35-2016, the County Executive and County Council approved  
11 Capital Projects for the Revenue Authority’s Capital Improvement Program which included  
12 project number WM900812 Suitland Project; and

13 WHEREAS, Section 21A-119 of the Prince George’s County Code provides that where  
14 modifications are required to a capital project of the Revenue Authority, the capital improvement  
15 program shall be amended in the same manner as originally approved; and

16 WHEREAS, CB-32-2016 the Annual Budget and Appropriation Ordinance of Prince  
17 George’s County for Fiscal Year 2017 included a general fund transfer; and

18 WHEREAS, additional appropriations as provided herein, and unanticipated revenues  
19 have been received from the State for capital projects.

20 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince  
21 George's County, Maryland, that the Approved FY 2017 Capital Budget of the Revenue  
22 Authority is hereby amended as follows:

SECTION 2. BE IT FURTHER RESOLVED that the Approved Fiscal Year 2017-2022 Capital Improvement Program is hereby amended as shown on Schedule A attached hereto and made part hereof, amending the total project cost and expenditures and revenue schedules for the aforementioned project.

NOW, THEREFORE, BE IT RESOLVED that this Resolution shall take effect upon the date of the adoption.
