Pursuant to the provisions of Article 28 of the Annotated Code of Maryland and the Zoning Ordinance of Prince George's County, being also Subtitle 27 of the Prince George's County Code, the Prince George's County Council, sitting as the District Council, public hearing to receive testimony on the proposed Regulating Plan for the Addison Road Metro Station and vicinity as part of to the Planning Board's *Adopted Subregion 4 Master Plan and Endorsed Sectional Map Amendment (SMA)*.
