Staff summarized the resolution informing the committee that in accordance with the approved FY 2007 Planning Department work program, CR-47-2006 initiates a Sectional Map Amendment for the Rural Tier as delineated in the 2002 Approved General Plan.

Maria Martin, of the Planning Department's Countywide Planning Division, was present to respond to questions and to provide an estimated schedule for the Plan preparation and adoption. Ms. Martin indicated the following tentative dates to ensure adoption of the Plan before the end of this year: Planning Board hearing in early September, transmittal of the Plan by the Planning Board in mid-September, public hearing by the County Council in October, and adoption of the Plan in December.

Chairman Dernoga requested that this schedule be included with the information concerning the Rural Tier Sectional Map Amendment that is posted on the Planning Department's website.

Bill Scott, President of the Croom Citizens' Association, addressed the committee regarding concerns that the Sectional Map Amendment is not being prepared in accordance with a Master Plan. Mr. Scott also indicated his association's concern with a potential 25-acre requirement for the O-S Zone and noted the preference of retaining the 5-acre, or a maximum of 10 acres, for this zoning category.

The approved FY 2007 Planning Department work program requires the initiation of a Sectional Map Amendment for the Rural Tier as delineated in the 2002 Prince George's County Approved General Plan. This resolution initiates the Rural Tier Sectional Map Amendment.
