WHEREAS, S	Section 21A-119 of the Prince George's County Code provides that the
Revenue Authority	of Prince George's County may propose one or more projects for inclusion in
the Authority's Cap	ital Improvement Program and that the County Executive shall transmit to the
County Council for	its approval by resolution or ordinance any such project approved by the
County Executive;	and
WHEREAS, t	he Capital Improvement Program for the Revenue Authority includes seven
projects; and	
WHEREAS, c	copies of the seven project descriptions are attached hereto as Attachment 1;
and	
WHEREAS, to	he Capital Budget for Fiscal Year 2003 totals \$4.9 million; and
WHEREAS, S	Section 21A-118 of the Prince George's County Code provides that if the
proposed operating	budget of the Authority includes any item to be funded from payments to be
received from the C	County that the anticipated receipts shall be identified for each item and a copy

of the proposed budget shall be transmitted by the Authority to the County Executive and the

County Council for their review and comment; and

WHEREAS, the Authority has forwarded its proposed operating budget to the County Executive and the County Council for review and comment as shown in Attachment 2.

SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that subject to and in accordance with the authority of the Charter of Prince George's County and pursuant to Subtitle 21A of the Prince George's County Code, the Capital Improvement Program for Fiscal Years 2003-2008 of the Revenue Authority of Prince George's County, as submitted by the County Executive to the County Council, a copy of which is attached hereto as Attachment 1 and incorporated herein by reference as though it was set forth fully herein, is hereby authorized, approved, and adopted.

SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the proposed Operating Budget, Fiscal Year 2002-2003, of the Revenue Authority of Prince George's County and concurs with the proposed Operating Budget of the Revenue Authority.
