RESOLUTION

1 A RESOLUTION concerning

2 Maryland-National Capital Park and Planning Commission

3 For the purpose of transferring certain appropriations and expenditures between certain programs
4 in the Fiscal Year 2021–22 Operating Budget for the Recreation Fund.

5 WHEREAS, the Annual Budget and Appropriation Ordinance for Fiscal Year 2021–22 for
6 the Maryland-National Capital Park and Planning Commission was adopted by CB-34-2021; and

7 WHEREAS, under the provisions of the Land Use Article, Section 18-108, the budget may
8 be amended by resolution by the respective County Councils on their initiative or at the request
9 of the respective County Executives, and after public hearing upon reasonable notice to the
10 public; and

11 WHEREAS, CB-34-2021 identified funding for certain recreation programs, in particular,
12 the Anacostia Watershed Society, Inc., and the Anacostia Trails Heritage Area, Inc.; and

13 WHEREAS, since the adoption of CB-34-2021, it has been determined that the allocation
14 of certain funding to the Anacostia Watershed Society, Inc., was in error as approved in the FY
15 2021–22 Maryland-National Capital Park and Planning Commission budget ordinance; and

16 WHEREAS, there is a need to increase or provide funding for the Anacostia Trails Heritage
17 Area, Inc.; and

18 WHEREAS, in order to identify funding for this recreation program, there is a need to
19 decrease funding in the Recreation Fund for the Anacostia Watershed Society, Inc.

20 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
21 County, Maryland, sitting as the District Council for that part of the Maryland-Washington

1 Regional District in Prince George's County, Maryland, that the following adjustments to the
2 approved Fiscal Year 2021–22 Maryland-National Capital Park and Planning Commission
3 Operating Budget Recreation Fund programs, as approved in CB-34-2021, are hereby made for
4 the purposes set forth above:
