**RESOLUTION**

A RESOLUTION concerning

Maryland-National Capital Park and Planning Commission

FY 1996 Capital Budget

For the purpose of amending the Prince George's County portion of the Maryland-National Capital Park and Planning Commission Capital Budget for Fiscal Year 1995-1996 to transfer appropriation authority to a General Park Needs Study project.

WHEREAS, Article 28, Section 2-118, of the Annotated Code of Maryland provides for the amendment of the Capital Budget of the Maryland-National Capital Park and Planning Commission (the "Commission") by the County Governing Body on its own initiative or at the request of the Commission and after public hearing upon reasonable notice to the public; and

WHEREAS, the Commission has requested an amendment to the Prince George's County portion of the Commission's Capital Budget for FY 1995-1996, as adopted by CB-36-1995, to transfer funding authority to a General Park Needs Study project in the amount of \$189,267; and

WHEREAS, the Commission has identified \$189,267 in a previously approved and funded project titled U.S. Air Arena (ECO50977); and

WHEREAS, the U.S. Air Arena project was approved in the FY 1995 Capital Budget, as adopted by CB-46-1994 in the amount of \$250,000; and

WHEREAS, the capital budget as adopted constitutes the total appropriation for projects previously authorized; and

WHEREAS, funding for this project was provided by Maryland-National Capital Park and Planning Commission bonds, and it has been determined that there is a fund balance in this project; and

WHEREAS, it has been determined that there is a need to conduct park need and/or feasibility studies, as required, throughout the County; and

WHEREAS, the County Executive has recommended to the County Council such amendment; and

WHEREAS, the County Council has conducted a public hearing on the proposed amendment having given reasonable notice thereof.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1995-1996 Maryland-National Capital Park and Planning Commission Capital Budget is revised to include the General Park Needs Study as shown in Attachment "A" attached hereto and made a part hereof.

BE IT FURTHER RESOLVED that the Fiscal Year 1995-1996 Capital Budget of the Maryland-National Capital Park and Planning Commission, as adopted by CB-36-1995, Section 4, is hereby amended to transfer these funds in accordance with the following schedule:
