2	(c) Legacy Comprehensive Design (LCD) Zone							
3	(1) The purpose of the Legacy Comprehensive Design (LCD) Zone is to recognize							
4	comprehensive design zones established prior to April 1, 2022 for which a Basic Plan,							
5	Comprehensive Design Plan (CDP), or Specific Design Plan (SDP) was approved prior to April							
6	1, 2022 or for lands that were subject to a Zoning Map Amendment (ZMA) and Basic Plan for a							
7	comprehensive design zone that was pending prior to April 1, 2022, and was approved pursuant							
8	to Section 27-1700, Transition Provisions, after April 1, 2022.

10	(6) <u>Grading Permit</u>							
11	Notwithstanding any other provision of this Subtitle, a grading permit to support the							
12	development of uses permitted in the LCD Zone may be issued by the Department of Permitting,							
13	Inspections, and Enforcement so long as it is in conformance with an approved CDP. The							
14	grading permit shall be limited to activities related to the installation of utilities, streets,							
15	stormwater management facilities, and lot grading based on the approved limits of disturbance as							
16	shown on the approved CDP or the approved Type 1 Tree Conservation Plan. An SDP and a							
17	Final Plat is not required for issuance of a grading permit under this subsection.
