**RESOLUTION**

1 A RESOLUTION concerning

2 Compensation of the Chairperson of the Prince George's County Planning Board

3 For the purpose of establishing and providing for the compensation of the Chairperson of the

4 Prince George's County Planning Board.

5 WHEREAS, Section 15-108 of the Land Use Article of the Annotated Code of Maryland  
6 governs the compensation of members of the Maryland-National Capital Park and Planning  
7 Commission; and

8 WHEREAS, upon recommendation from the County Executive, the County Council may  
9 authorize whatever compensation as may be deemed appropriate for the Chairperson of the  
10 Prince George's County Planning Board, designated to serve on a full-time basis; and

11 WHEREAS, the County Executive has recommended the compensation for that position;  
12 now, therefore;

13 SECTION 1. BE IT RESOLVED by the County Council of Prince George's County,  
14 Maryland, that the salary for the full-time Chairperson of the Prince George's County Planning  
15 Board be and the same is hereby established to be an amount equal to the maximum salary  
16 allowable for Grade G-42 in the General Schedule of the Prince George's County Salary Plan,

1 retroactive to his start date of July 8, 2025, as such Salary Plan may be adjusted from time to  
2 time for cost of living or other purposes.

3 SECTION 2. BE IT FURTHER RESOLVED that, in addition to salary, the full-time  
4 Chairperson of the Prince George’s County Planning Board shall be entitled to the fringe benefits  
5 for full-time employees of the Maryland-National Capital Park and Planning Commission, and  
6 shall accrue annual leave on the basis of thirty (30) days per year and sick leave on the basis of  
7 one hundred-twenty (120) hours per year, and will start each term with an annual leave credit of  
8 80 hours and sick leave credit of 80 hours.

9 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
10 County, Maryland, that the full-time salary of Chairperson of the Prince George’s County  
11 Planning Board, be an amount equal to the maximum salary allowable for Grade G-42 in the  
12 General Salary Schedule, retroactive to his start date of July 8, 2025.
