





- DPR recently hired a paleontologist (September 2025)
- Next Step: Immersive 3-mile Nature and History Trail that showcases the majestic animals that ruled our earth for more than 150 million years. Connecting Dinosaur Park with historic site Abraham Hall, visitors walk through the woods to learn about the history and heritage of Prince George's County – from Black community and culture to natural wonders to pre-historic creatures.

## Temple Hills Community Center

- To fund the proposed renovation of the Temple Hills Community Center, \$9 million was re-purposed from two other projects in FY26 - \$5 million from Publick Playhouse (PDF 551837) and \$4 million from Dinosaur Park Science Center (PDF 499283). **The funds will be returned to the projects in FY27.** Since the projects have not started, this change in funding does not adversely affect the projects at this time. For example, DPR has existing funds to start the architectural design process for Publick Playhouse.
- The additional \$20 million in PAYGO was authorized by the County Council in October 2025.

## Capitol Heights Splash Park

- DPR increased the funding from the requested \$2 million to \$2.5 million. Since a site has not been identified, the additional funds may support project scope and deliverables that have not yet been identified, such as necessary site infrastructure needed (utility services, parking, etc...).
- \$1.1 million in funding will come from the proposed FY26 funding for Publick Playhouse (PDF 551837) and will be replenished in FY27.

## Capitol Heights Splash Park

- DPR increased the funding from the requested \$2 million to \$2.5 million. Since a site has not been identified, the additional funds may support project scope and deliverables that have not yet been identified, such as necessary site infrastructure needed (utility services, parking, etc...).
- The funding will come from the proposed FY26 funding for Publick Playhouse (PDF 551837) and will be replenished in FY27.

## Temple Hills Dog Park

- DPR increased the funding from \$500,000 to \$750,000 to support this request. Since a site has not been identified, the additional funds may support project scope and deliverables that have not yet been identified, such as necessary site infrastructure needed (utility services, parking, etc...).
- \$750,000 was moved from Cosca Regional Park Master Plan Implementation (PDF 299274) in FY26. The Department will use existing funding to move forward at Cosca Regional Park.

## Seat Pleasant Park

- \$200,000 was moved from Cosca Regional Park Master Plan Implementation (PDF 299274) in FY26. The Department will use existing funding to move forward at Cosca Regional Park.

## ATV Park Feasibility Study

- DPR established a new project with \$250,000 to conduct a feasibility study for the proposed ATV Park. The study will examine potential locations, operating impacts, lessons learned from other municipalities, and future CIP requests.
- The funds came from Recreation Facility Planning (PDF 501272).

# ADDITIONAL PROJECTS REQUESTED

## District Heights Dog Park

- DPR has an existing PDF for dog parks in the central area of the County (PDF 499289) with a balance of \$1.2 million. The PDF description was updated to include a dog park for the area surrounding District Heights.

# ADDITIONAL PROJECTS REQUESTED

## District Heights Basketball Renovation

- DPR supported the City of District Heights through the use of Program Open Space (POS) Funds. District Heights is not in the Metropolitan District, so DPR cannot expend CIP funds to District Heights. However, after a discussion with the City Manager, DPR proposed:
- add \$250,000 to the POS funds for District Heights in FY26 to complete the renovation of an outdoor basketball court.
- Work with District Heights over the next year to support FY27 POS funds for the renovation of the indoor basketball court.

# ADDITIONAL PROJECTS REQUESTED

## Service Area 7 Aquatic Center

- DPR's CIP has \$30 million in existing CIP funds for a new Aquatic Center in Service Area 7. The Department has an active feasibility study to prioritize the identification of a property to best fit this new facility.

# ADDITIONAL PROJECTS REQUESTED

## Children's Zone Indoor Facility Ages 2-5

- DPR will continue this conversation with the Council to determine the size and scope of the project. The Children's Indoor Zone could be an additional feature to a future aquatic or community center.
- Council added \$500,000 to the operating budget new program initiatives to move this project forward.
