**RESOLUTION**

1 A RESOLUTION concerning

2 Adjustments to Approved Position Grades

3 For the purpose of adjusting the number of positions in each grade to the Police Department,  
4 Office of the Sheriff, and Office of Homeland Security.

5 WHEREAS, CB-14-2007, amended, adopted and enacted the Annual Budget and  
6 Appropriation Ordinance of Prince George’s County for Fiscal Year 2007-2008, which set forth  
7 the number of positions by grade; and

8 WHEREAS, pursuant to Section 815(b) of the Charter for Prince George’s County,  
9 Maryland, during any fiscal year, no agency of County government may exceed the number of  
10 positions in each grade for that agency as approved in the operating budget without the prior  
11 approval of the Council; and

12 WHEREAS, to implement Section 815(b) of the Charter for Prince George’s County,  
13 Maryland, the Council upon recommendation of the County Executive, may, by resolution, make  
14 additional amendments to the number of positions in each grade for a particular agency which  
15 were not included in the budget for the current fiscal year; and

16 WHEREAS, the number of positions in each grade for the agencies referenced in CB-14-  
17 2007, as amended, in Attachment B have been amended and are attached hereto and made a part  
18 hereof; and

19 WHEREAS, the County Executive has duly recommended that the grade level amendments  
20 be made.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
22 County, Maryland, that the Fiscal Year 2007-2008 Approved Current Expense Budget,
