<u>INVOCATION</u> – The Invocation was provided by Mr. Edwin H. Brown, Jr., Member of From the Heart Church Ministries in Temple Hills, Maryland. Council Member Hendershot requested prayer for the niece of Lynda Bowman (Council Staff) who was critically ill.

<u>PLEDGE OF ALLEGIANCE</u> – The pledge of allegiance was led by Council Member Dernoga.

CONSIDERATION OF EXECUTIVE VETO

<u>CB-73-2003 (DR-2) (SUBDIVISION BILL) – AN ACT CONCERNING SUBDIVISIONS – FUNDING FOR PUBLIC ROAD FACILITIES</u> for the purpose of amending the criteria for approving a subdivision when adequate public road facilities are programmed for construction. - *VETO SUSTAINED*

Enacted by the Council on 11/25/2003 by a 7-1 vote. In favor: Council Members Bland, Dean, Dernoga, Exum, Harrington, Knotts and Peters. Opposed: Council Member Hendershot. Absent: Council Member Shapiro. Vetoed by the County Executive on 12/18/2003.

Chairman Knotts proffered the question: "Shall the earlier action of the Council be affirmed notwithstanding the objections of the executive?" Chairman Knotts called for the vote. Under discussion, Council Members Dernoga, Peters, Exum, and Dean expressed their disappointment in the County Executive's veto of this legislation, speaking to the process used and the lack of any prior opposition to the bill. Council Members Hendershot and Bland spoke in opposition to the bill and support of the veto. The question failed 5-4 (Opposed: Chairman Knotts and Council Members Bland, Hendershot and Shapiro.) Chairman Knotts requested that the stakeholders work with the Planning, Zoning and Economic Development Committee and the Transportation, Housing and the Environment Committee to craft legislation that will best serve the citizens of Prince George's County.
