RESOLUTION

A RESOLUTION concerning

Financing of Henson Creek Manor II

For the purpose of approving the financing of the construction of the Henson Creek Manor II Project by Henson Creek Manor II Associates Limited Partnership through the Community Development Administration (CDA).

WHEREAS, there is a significant need for affordable rental units in Prince George's County; and

WHEREAS, Henson Creek Manor II Associates Limited Partnership proposes to construct a 105 unit garden apartment complex known as Henson Creek Manor II on a site adjacent to 5301 Haras Place, Fort Washington, Maryland; and

WHEREAS, the CDA has received an application from the Henson Creek Manor II Associates Limited Partnership for financing the construction of the Henson Creek Manor II Project in an amount not to exceed Eight Hundred Fifty Thousand Dollars (\$850,000) from the Rental Housing Production Program; and

WHEREAS, Henson Creek Manor II Associates Limited Partnership has requested and has received a commitment of County HOME funds in the amount of \$300,000; and

WHEREAS, Article 83B, Sections 2-501 through 2-510 of the Annotated Code of Maryland, as amended require a local government resolution approving the use of State funds within the jurisdiction; and

WHEREAS, the County Executive endorses and recommends approval for financing the Henson Creek Manor II Project as more fully described in Attachment A, attached hereto and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the financing of construction proposed by CDA of the Henson Creek Manor II project is hereby approved in an amount not to exceed Eight Hundred Fifty Thousand Dollars (\$850,000).
