BACKGROUND INFORMATION/FISCAL IMPACT:

Charter Section 811 requires that each year, after the budget is finally adopted, the County Council must approve a Resolution causing to be raised the amount of taxes required by the budget in the manner provided by law so that the budget shall be balanced as to proposed income and expenditures. Since the Council adopted the Annual Budget Ordinance on May 27, 2021, this Resolution will set the corresponding tax rates for Fiscal Year 2022.
