**RESOLUTION**

1 A RESOLUTION concerning

2 Housing and Community Development

3 Annual Action Plan: FY 2015

4 For the purpose of amending the County’s Fiscal Year (“FY”) 2015 Annual Action Plan for  
5 Housing and Community Development by restructuring Community Development Block Grant  
6 (“CDBG”) activities from the FY 2014 and FY 2015 Annual Action Plans.

7 WHEREAS, pursuant to Section 15A-107 of the Prince George’s County (the “County”)  
8 Code, the County Executive submitted a citizen participation plan in conjunction with the FY  
9 2016 – 2020 Consolidated Plan for Housing and Community Development to the County  
10 Council; and

11 WHEREAS, the citizen participation plan was adopted by CR-8-2015 and provided for  
12 citizen involvement in the various stages of housing and community development activities and  
13 listed the actions which are subject to the citizen participation plan; and

14 WHEREAS, pursuant to Section 15A-105(a)(1) of the County Code, the FY 2015 Annual  
15 Action Plan for Housing and Community Development must be amended to include a detailed  
16 description of recommended housing and community development activities proposed for  
17 implementation during the succeeding program year; and

18 WHEREAS, prior Annual Action Plans included the projects within CDBG Program Years  
19 39 and 40 (i.e., FY 2014 and FY 2015), attached hereto as “Attachment A” and made a part  
20 hereof; and

21 WHEREAS, the amended FY 2015 Annual Action Plan restructures activities related to  
22 housing and community development from the FY 2014 and FY 2015 Annual Action Plans,

1 attached hereto as "Attachment B" and made a part hereof .

2 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
3 County, Maryland, that the FY 2015 Annual Action Plan for Housing and Community  
4 Development is hereby amended to restructure and approve CDBG activities from the FY 2014  
5 and FY 2015 Annual Action Plans, as described in Attachments "A" and "B".

6 BE IT FURTHER RESOLVED that upon the adoption of this Resolution, it shall be  
7 transmitted to the County Executive, by the Clerk of the Council, to submit the amended Annual  
8 Action Plan to the U.S. Department of Housing and Urban Development.
