A RESOLUTION concerning

Electrical Permit Fees

For the purpose of simplifying and updating the current schedule of permit fees for electrical permits.

WHEREAS, Section 9-121 of the Prince George's County Code provides that permit fees for electrical permits shall be proposed by the County Executive and adopted by the County Council by resolution following a public hearing; and

WHEREAS, a schedule of permit fees for electrical permits was approved by CR-35-1996; and

WHEREAS, the County Executive has proposed and recommended revised permit fees for electrical permits;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the electrical permit fees included herein be and the same are hereby approved in accordance with the provisions of Section 9-121 of the Prince George's County Code.
