**RESOLUTION**

1 A RESOLUTION concerning  
2 Maryland-National Capital Park and Planning Commission – Prince George’s County Members -  
3 Geographic Balance

4 For the purpose of addressing the geographic distribution and balance of the membership of the  
5 Maryland-National Capital Park and Planning Commission and confirming Sarah Ann Cavitt as  
6 a member.

7 WHEREAS, Section 2-101 of Article 28 of the Annotated Code of Maryland requires that,  
8 in making and approving appointments to the Maryland-National Capital Park and Planning  
9 Commission, the County Council and County Executive shall attempt to provide reasonable  
10 geographic balance with respect to the places of residence of the members; and

11 WHEREAS, Section 2-101 further requires that the appointment resolution for each  
12 appointment shall describe the resulting geographic distribution and provide appropriate  
13 explanations; and

14 WHEREAS, the County Executive has duly nominated Sarah Ann Cavitt, a resident of Fort  
15 Washington, to replace William Eley, a resident of Cheverly, whose term has expired; and

16 WHEREAS, a public hearing on the nomination and confirmation of Ms. Cavitt has been  
17 held; and

18 WHEREAS, the remaining four members of the Commission from Prince George’s County  
19 are residents of Fort Washington, Glenn Dale, Palmer Park, and Riverdale respectively.

20 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
21 County, Maryland, that, with the appointment of Sarah Ann Cavitt to the Maryland-National  
22 Capital Park and Planning Commission, there continues to be reasonable geographic distribution

1 with respect to the places of residence of the members of the Commission from Prince George's  
2 County.

3 BE IT FURTHER RESOLVED that Sarah Ann Cavitt is hereby confirmed as a member of  
4 the Maryland-National Capital Park and Planning Commission, replacing William Eley, Jr., with  
5 a term expiring June 10, 2010.
