RESOLUTION

A RESOLUTION concerning

The Listing of Local Questions on the 1998 Ballot

For the purpose of designating the order and certifying the form in which local questions shall be placed on the 1998 ballot.

WHEREAS, Article 33, Section 16-6 of the Annotated Code of Maryland provides that the County Council shall designate the order and certify the form in which local questions shall appear on the ballot.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the order and form in which local questions shall appear on the ballot for the November, 1998 general election shall be as follows:

QUESTION A

COUNTY BUILDINGS BONDS

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$6,000,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of County Buildings, as defined therein.

QUESTION B

PUBLIC WORKS AND TRANSPORTATION FACILITIES BONDS

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$57,176,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or

repair of Public Works and Transportation Facilities, including the acquisition of sites therefor, as defined therein.

QUESTION C

LIBRARY FACILITIES BONDS

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$1,807,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Library Facilities, including the acquisition of site therefor, as defined therein.

QUESTION D

COMMUNITY COLLEGE FACILITIES BONDS

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$2,148,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Community College Facilities, including the acquisition of sites therefor, as defined therein.

QUESTION E

PUBLIC SAFETY FACILITIES BONDS

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$3,790,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Public Safety Facilities (including Department of Corrections Facilities and Fire Department Facilities), including the acquisition of sites therefore, as defined therein.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Board of Supervisors of Elections by the Clerk of the Council. Adopted this <u>28th</u> day of <u>July</u>, 1998.
