## ZONING BILL

AN ORDINANCE concerning

Minor Changes to Site Plans for

Special Exceptions

FOR the purpose of permitting the Planning Board to approve minor changes to a site plan for approved Special Exceptions for public electric utility uses or structures.

BY repealing and reenacting:

Section 27-325,

The Zoning Ordinance of Prince George's County, Maryland,

being also

SUBTITLE 27. ZONING.

The Prince George's County Code (1987 Edition, 1989 Supplement).

SECTION 1. BE IT ENACTED by the County Council of Prince
George's County, Maryland, sitting as the District Council for that
part of the Maryland-Washington Regional District in Prince George's
County, Maryland, that Section 27-325 of the Zoning Ordinance of
Prince George's County, Maryland, being also Subtitle 27 of the
Prince George's County Code, be and the same is hereby repealed and
reenacted with the following amendments:

#### DIVISION 1. ADMINISTRATIVE PROCEDURES.

Subdivision 10. Amendments of Approved Special Exceptions.

Sec. 27-325. Minor Changes.

\* \* \* \* \* \* \* \*

- (1) Changes of site plans for public electric utility uses or structures.
- (1) The Planning Board may permit changes to a site plan for approved public electric utility uses or structures for the addition, relocation, or modification of foundations and equipment, including ground wires, control houses and associated structures, within the existing fence line.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect on the date of its adoption.
