#### TRANSPORTATION, HOUSING & THE ENVIRONMENT COMMITTEE

Committee Vote: Favorable as Amended, 4-0 (In favor: Council Members Harrington, Dean, Knotts and Peters).

Staff explained the purpose of CR-17-2004 and informed the Committee of referral comments that were received at the public hearing held on April 27, 2004. The Director of the Department of Housing and Community Development (DHCD) explained the Community Development Block Grant (CDBG) proposal submittal process that represents seven months of work by the Department, municipalities, other government agencies and non-profit public service agencies. The Plan serves as the application to Housing Urban Development (HUD) for the CDBG funds, the Home Investment Partnership Program and the Emergency Shelter Grant Program. The Director indicated that for Program Year 30, 109 project proposals for CDBG totaling over \$19 million were received against the \$7,678,000 available. The County's CDBG allocation is 2% less than last year. This decrease is due to calculations based on the Congressional appropriations. Projected "program income" from HUD funded activities is higher in FY2005, making the total amount available the same, \$7,678,000.

The Annual Plan allocates the maximum funding allowed by law to the eligible categories: Public Service Projects

(15%) and Program Planning and Administration (20%). The remaining \$5,049,000 million is allocated among the eligible activities; acquisition and rehabilitation; economic development; relocation and public facilities.

The DHCD Director indicated that funding is recommended for Independence NOW, Access Housing Program, in the amount of \$25,000. He further recommended that the Prince George's Office of Community Relations, Youth Leadership and Employment Program be funded at \$50,000.

The Office of Law presented a proposed Draft 2 for the Committee's consideration. Prince George's County is entitled to receive \$218,347 for FY 2003 and \$257,665 for FY 2004, totaling \$476,002, in American Dream Down payment Partnership Program (ADDI). ADDI is a new component under the HOME investment Partnership Program (HOME). Draft 2 contains clauses adding ADDI to the Annual Action Plan. This Program will provide down payment assistance to low-income families who are first-time homebuyers for the purchase of single-family housing. The DHCD Director indicated that outsourcing the ADDI program to nonprofit housing entities would be an option for administering the ADDI program. The Transportation, Housing and Environment Committee agreed that this would be a preferred option for the carrying out the ADDI objectives. This would be a viable option since administrative fees are not allocated directly from ADDI. Administrative cost up to 10% of the 2003 ADDI amount would have to be absorbed by the HOME Program's administrative line budget.

The Transportation, Housing and Environment Committee reviewed the Annual Action Plan, focusing on each of the above-mentioned categories and proposed changes as reflected in CR-17-2004 Draft 2.

The Committee requested the Department of Public Works and Transportation provide the Committee with their original priority list of infrastructure projects prior to the adoption of CR-17-2004 Draft 2. Under "Public Facilities," the Committee reduced the proposed amount of funding for the Prince George's County Department of Public Works and Transportation, "Infrastructure Redevelopment and Blight Removal," from \$330,000 to \$310,000 and stipulated that \$10,000 go towards planning for A/E cost for Forest Heights street improvements.

The Committee removed funding from the Dimensions Healthcare System and the Police Department and will consider other funding sources for these programs.

The Office of Law and the Legislative Officer find CR-17-2004 Draft 2 to be in proper legislative form
