**ZONING BILL**

1 AN ORDINANCE concerning

2 Private Limousine Service Dispatching Stations in the I-3 Zone

3 For the purpose of clarifying the requirements set forth in the Zoning Ordinance for Private  
4 Limousine Service Dispatching Stations, a permitted use, in the I-3 (Planned Industrial –  
5 Employment Park) Zone, under certain specific circumstances.

13 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
14 Maryland, sitting as the District Council for that part of the Maryland-Washington Regional  
15 District in Prince George's County, Maryland, that Section 27-473 of the Zoning Ordinance of  
16 Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code,  
17 be and the same is hereby repealed and reenacted with the following amendments:

**60** Provided the use is on property with a land area of at least five (5) acres. Notwithstanding any other provision within Section 27-471 of this Subtitle to the contrary, a Private Limousine Service Dispatching Station use situated on five (5) or more acres of land where a business was operating within the definition of 'Private Limousine Service Dispatching Station' set forth in Section 27-107.01 of this Subtitle, and for which no new development requiring a County building permit is proposed, shall be a permitted use and shall only conform with the requirements set forth in Section 27-471 of this subtitle if development to expand the use requires a County building permit.
