PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT Date: 10/21/99

Committee Vote: Favorable, 5-0, (In favor: Council Members Wilson, Hendershot, Maloney, Russell and Scott).

This resolution will amend the Salary Plan in Salary Schedule A for employees represented by Council 67, AFSCME, AFL-CIO and its affiliated Local 2462 (employees in labor and trade classifications in the Department of Public Works and Transportation (DPWT), Department of Environmental Resources (DER), Office of Central Services (OCS), and Bureau of Apparatus Maintenance Unit in the Fire/EMS Department), and Local 2735 (employees in various professional, paraprofessional, clerical and administrative classifications in DPWT, DER, Department of Family Services and Department of Housing and Community Development) and reflects modifications of the new two year collective bargaining agreement. (FY2000 – FY2001).

The highlights of the Salary Plan and the fiscal impact are included in CB-86-1999.

BACKGROUND INFORMATION/FISCAL IMPACT

This is companion legislation to the Bills to approve the collective bargaining agreements between the County and Council 67, American Federation of State, County and Municipal Employees, AFL-CIO and its affiliated Local 2462 and 2735 and Local 2462 (Fire/EMS Department Bureau of Apparatus Maintenance Unit) for Fiscal Years 2000 and 2001. This Salary Schedule reflects modifications of the agreement. The estimated fiscal impact will be provided by the Office of Management and Budget.
