3 For the purpose of recognizing April 2022 as National County Government Month

5 Americans provide essential services to create healthy, safe and vibrant communities; and

6 WHEREAS, counties provide public health services, administer justice, keep communities  
7 safe, foster economic opportunities and much more; and

8 WHEREAS, Prince George's County and all counties take pride in our responsibility to protect  
9 and enhance the health, wellbeing and safety of our residents in efficient and cost-effective ways; and

10 WHEREAS, under the leadership of National Association of Counties President Larry  
11 Johnson, NACo is demonstrating how "Counties THRIVE," especially in supporting residents and  
12 businesses during the coronavirus pandemic; and
