AN ACT concerning

Supplementary Appropriations in the Approved Fiscal Year 2010 Capital Budget For the purpose of providing a supplementary appropriation to the Waste Transfer Station capital project in the amount of \$11,675,000.

WHEREAS, the Charter of Prince George's County, Maryland provides for the adoption of the County budget, which includes the capital budget and capital program; and

WHEREAS, pursuant to CB-19-2009, the County Budget, known as the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 2010, which includes the Fiscal Years 2010-2015 Capital Improvement Program - Fiscal Year 2010 Capital Budget was adopted and amended; and

WHEREAS, the Approved Fiscal Year 2010-2015 Capital Improvement Program sets forth the plan of the County to receive and expend funds for capital projects during the fiscal year covered by the capital budget and the next succeeding five fiscal years thereafter and also the means of financing said projects; and

WHEREAS, pursuant to Section 815 of the Charter for Prince George's County, Maryland, the County Council, upon recommendation by the County Executive, may, by legislative act, make additional or supplementary appropriations from revenues received from anticipated sources but in excess of budget estimates therefor, from revenue received from sources not anticipated in the budget for the current fiscal year and from any prior year available and uncommitted fund balance; and

WHEREAS, additional appropriations as provided herein, and certain additional revenue

1 have been identified; and 2 WHEREAS, the County Executive deems it desirable to provide additional appropriations 3 for the Waste Transfer Station (NX548925) as currently existing appropriations are inadequate; 4 and WHEREAS, pursuant to Sections 815 and 820 of the Charter, the County Executive 5 6 recommends that this supplementary appropriation be made; now, therefore, 7 SECTION 1. BE IT ENACTED by the County Council of Prince George's County, 8 Maryland, that the Fiscal Year 2010 Approved Capital Budget is hereby amended, to provide 9 supplementary appropriations as follows: TO: 10 Orig.
