#### Transportation, Housing and Environment

**Date 4/22/2010**

Committee Vote: No recommendation 4-0-1 (In favor: Council Members Olson, Knotts, Turner and Harrison, Abstention - Dernoga).

The December 2009 Cycle of Amendments to the 2008 Water and Sewer Plan contains Two (2) applications requesting water and/or sewer category changes.

The Committee did not have any recommendations on the of the County Executive's recommendations on the following two (2) category change applications: 09/W-04 Manor Gate (Retain 5), 09/P-04 Erco Property (Retain 5).

The Committee had no recommendation on CR -19-2010.

**BACKGROUND INFORMATION/FISCAL IMPACT:**

(Includes reason for proposal, as well as any unique statutory requirements)

The 2008 Water and Sewer Plan provides for three cycles of category change requests annually to amend the Plan. This Resolution represents the December 2009 Cycle of Amendments.

The 2008 Water and Sewer Plan was adopted by CR-91-2008, and amended by CR-17-2009, CR-52-2009, and CR-5-2010. The December 2009 Cycle contains two (2) requests for a category change.

One (1) category change request is in the Western Branch sewershed, and one (1) in the Piscataway sewershed.

Environment Article, Title 9, Subtitle 5, of the Maryland Annotated Code, sets procedures for amendments and revisions to the Plan. At least 30 days prior to the public hearing on the amendments, the County Council must submit to the Washington Suburban Sanitary Commission and Maryland-National Capital Park and Planning Commission a copy of the resolution for their recommendations.

5/11/2010 - CR-19-2010 was amended on the floor as follows:  
09/P-04 Erco Property Change from 5 to 4; CR-19-2010 DR-2 was adopted.
