RESOLUTION

1 A RESOLUTION concerning
2 Maryland-National Capital Park and Planning Commission – Prince George’s County Members -
3 Appointment and Geographic Balance

4 For the purpose of addressing the geographic distribution and balance of the membership of the
5 Maryland-National Capital Park and Planning Commission and confirming Elizabeth M. Hewlett
6 to serve as a member of the Maryland-National Capital Park and Planning Commission and as
7 Chairperson of the Prince George’s County Planning Board to serve on a full-time basis.

8 WHEREAS, Section 2-101 of Article 28 of the Annotated Code of Maryland requires that,
9 in making and approving appointments to the Maryland-National Capital Park and Planning
10 Commission, the County Council and County Executive shall attempt to provide reasonable
11 geographic balance with respect to the places of residence of the members; and

12 WHEREAS, Section 2-101 of Article 28 of the Annotated Code of Maryland further
13 requires that the appointment resolution for each appointment shall describe the resulting
14 geographic distribution and provide appropriate explanations; and

15 WHEREAS, the County Executive has duly nominated Elizabeth M. Hewlett, a resident of
16 Bowie, to serve as a member of the Maryland-National Capital Park and Planning Commission
17 and to serve on a full-time basis as Chairperson of the Prince George’s County Planning Board;
18 and

19 WHEREAS, a public hearing on the nomination and confirmation of Ms. Hewlett has been
20 held; and

21 WHEREAS, the remaining four members of the Commission from Prince George’s County
22 are residents of Temple Hills, Glenn Dale, Bowie, and Fort Washington respectively.

1 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
2 County, Maryland, that, with the appointment of Elizabeth M. Hewlett to the Maryland-National
3 Capital Park and Planning Commission, there continues to be reasonable geographic distribution
4 with respect to the places of residence of the members of the Commission from Prince George's
5 County.

6 BE IT FURTHER RESOLVED that Elizabeth M. Hewlett is hereby confirmed as a member
7 of the Maryland-National Capital Park and Planning Commission and as Chairperson of the
8 Prince George's County Planning Board, with a term expiring June 15, 2014.
