RESOLUTION

1 A RESOLUTION concerning

2 Maryland – National Capital Park and Planning Commission

3 For the purpose of transferring certain appropriations and expenditures between certain programs
4 in the FY 2017-18 Operating Budget for the Recreation Fund.

5 WHEREAS, the Annual Budget and Appropriation Ordinance for Fiscal Year 2017-18 for
6 the Maryland-National Capital Park and Planning Commission was adopted by CB-54-2017; and

7 WHEREAS, under the provisions of the Land Use Article, Section 18-108, the budget may
8 be amended by resolution by the respective County Councils on their initiative or at the request
9 of the Commission after receipt of recommendations from the respective County Executives, and
10 after public hearing upon reasonable notice to the public; and

11 WHEREAS, CB-54-2017 identified funding for a recreation program entitled Daughter for
12 the Day Program (Senior Services) – Dist. 7; and

13 WHEREAS, since the adoption of CB-54-2017, it has been determined that this program is
14 no longer operating; and

15 WHEREAS, there is a need to provide funding for two recreation programs, entitled 100
16 Black Men of Prince George's County – Dist. 7, and Foundation for the Advancement of Music
17 and Education – Dist. 7; and

18 WHEREAS, in order to identify funding for these recreation programs, there is a need to
19 decrease funding in the Recreation Fund for the Daughter for the Day Program (Senior Services)
20 – Dist. 7.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
22 County, Maryland, that the following adjustments to the approved Fiscal Year 2017-18

1 Maryland-National Capital Park and Planning Commission Operating Budget Recreation Fund
2 programs, as approved in CB-54-2017, are hereby made for the purposes set forth above:
