any liability in excess of the amounts appropriated and no such payment shall be made, nor any	
obligation or liability incurred, except for purchase in an amount to be fixed by legislative act;

WHEREAS,	, the County desires to enter into a contract with BPI Mechanical Construction,
RSC Electrical & Mechanical Contractors, Inc., Specialty Construction Management, Inc.,	
XL Construction, LLC, and Innovation Mechanical, Inc., to provide heating, ventilation and air	
conditioning maintenance and repair services; and	
WHEREAS,	, the contract between Prince George's County, Maryland and BPI Mechanical
Construction, RSC Electrical & Mechanical Contractors, Inc., Specialty Construction	
Management, Inc., XL Construction, LLC, and Innovation Mechanical, Inc., will be conducted	
pursuant to the terms and conditions contained herein as Attachment A.
