Committee of the Whole

Committee Vote: Favorable, 9-0 (In favor: Council Members Dernoga, Turner, Olson, Campos, Exum, Dean, Bland, Harrison and Knotts)

Staff provided a summary of the resolution and referral comments that were received. CR-89-2010 amends the Prince George's County 2002-2011 Ten Year Solid Waste Management Plan by adding Recycle One Center located at 4700 Lawrence Street, Hyattsville, Maryland. The facility is privately owned. This facility accept Municipal Solid Waste generated in Prince Georges County. All incoming loads will be weighted and inspected to insure that only acceptable materials are delivered. The materials will be loaded onto transfer vehicles and sent to approved municipal waste sanitary landfills. This property sits on 2.8 acres.

A public hearing on the resolution was held October 26, 2010.

The Office of Law determined that CR-89-2010 was in proper legislative form.

The Office of Audits and Investigation indicated there will not be a negative fiscal impact on the County as a result of adopting CR-89-2010.

**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will add the RecycleOne Transfer Station to the County Solid Waste Plan. Environmental Article, Title 9, Subtitle 5, of the Maryland Annotated Code sets procedures for amendments and revisions to the Plan. Under the Code at least 30 days prior to the public hearing on the amendments, the County Council must submit to Washington Suburban Sanitary Commission (WSSC) and the Maryland-National Capital Park & Planning Commission (M-NCPPC), a copy of the proposed resolution for their recommendations. In addition, the resolution requires that the County Council submit a copy of the proposed resolution to residents in close proximity to the site location.
