**BACKGROUND INFORMATION/FISCAL IMPACT:**

The legislation is required pursuant to Section 819 of the Prince George's County Charter. Section 819 requires personal service contracts exceeding an aggregate of One Hundred Thousand Dollars (\$100,000.00) per contractor or an aggregate of Five Hundred Thousand Dollars (\$500,000.00) for all other multi-year contracts must be approved by resolution of the County Council upon notice and public hearing.

This contract is to engage Avolve Software Corporation to develop a web-based electronic plan review services and software activities using ProjectFlow to integrate with the new Permitting and Licensing System. The software, ProjectFlow, would ensure that the plan review accelerates the permitting process, making it fast and easy to submit, review documents and drawings, process corrections, and monitor and improve the work process. Avolve Software Corporation would deliver better service by reducing review time, help accelerate economic growth, and eliminate the inefficiency of paper movement and storage.
